

## **White Oak Township Regular Board Meeting March 12, 2018**

Trustee John Kemler called the regular board meeting to order at 7:30 p.m. on Monday, March 12, 2017. Roll call as follows: Supervisor Dorwin Marshall, Treasurer Aaron Graf, Clerk Leela Vernon, Trustee Diane Graf, Trustee John Kemler, and Zoning Administrator Rick Martinez. A Motion was made by Treasurer Graf, seconded by Trustee Kemler to approve the Park minutes as printed and placed on file. Motion Carried.

After 11 am they will accept other refuse from township residents at an additional fee.

Roll call vote as follows: John Kemler-Yes, Dorwin Marshall-Yes, Diane Graf-Yes, Aaron Graf-Yes, Leela Vernon-Yes. Resolution adopted 3-12-2018.

Trustee Graf mad a motion to allow the DCAA to use the White Oak Township Park baseball fields for their Varsity Softball games. The DCAA will do the necessary work to make the fields regulation. Motion seconded by Treasurer Graf. Motion carried.

A motion was made by Trustee Graf, seconded by Trustee Kemler to pay bills as presented. Motion carried.
