Supervisor Marshall has signed the letter of engagement and it was forwarded to Mike Homier by Aaron Graf, Deputy Treasurer.

Trustee Kemler made the motion, seconded by Trustee Graf to approve the quote submitted by Mark Collins to maintain the Township park fields. Motion carried.

Trustee Kemler made the motion to approve the PA116 applications for Dale Walker and James Glenn. Seconded by Trustee Graf. Motion carried.

Trustee Graf made a motion to pay bills as presented, seconded by Trustee Kemler. Motion carried.

Jim Greier from the DCAA took the floor to thank us for the use of the part and to ask if it was ok to put stakes in the ground, which would be level with the ground. They would help him when marking the fields. He will get the Township a schedule so we know when they will be using the park.

Trustee Graf mentioned our donation to the North Stockbridge Cemetery. Clerk Vernon will check to see if we are up to date on our agreed upon donation.
